

CCLBA Board of Directors Meeting Minutes 3:00pm Thursday, August 26, 2021 Calhoun County Building – Marshall Via ZOOM Video Conference Call

1. Call to Order

Ms. Trout-Edwards provided an update on the Eastside Redevelopment Project, commenting that work on arsenic present on the site is being reviewed by the environmental consultant and the developer.

Mr. Wensauer asked about the status of the adjacent property owned by Oaklawn Hospital.

Ms. Trout-Edwards stated that staff would like to resolve the environmental situation on the north parcel, which is likely naturally occurring, before moving forward with work on the south parcel. Therefore, environmental work will begin on the southern parcel when a resolution is determined.

Ms. Trout-Edwards also highlighted the recent support of the Land Bank's request for ARPA funds by the County's Board of Commissioners and that their support has laid the ground work for additional support from the State (MSHDA) and partnerships with local municipalities.
